Lieutenant Colonel James Peter ("Pete") Ferrell currently serves as the Chief of Miltiary Justice Policy within the Military Justice and Policy Division, Military Justice and Discipline Directorate, Joint Base Andrews, Maryland (JAJM) JAJM provides counsel on military justice to senior leaders, as well as guidance on military justice policy and processes to legal offices at every level of command. JAJM also represents the Department of the Air Force on the Joint Service Committee on Military Justice, an inter-agency, joint body dedicated to ensuring the Manual for Courts-Martial and Uniform Code of Military Justice constitute a comprehensive body of criminal law and procedure.

Lt Col Ferrell received received a direct commission as an Air Force Judge Advocate in December 2009 and entered active duty in January 2010. He is admitted to practice law before the Tennessee Supreme Court, the Air Force Court of Criminal Appeals and the United States Court of Appeals for the Armed Forces.
