Mr. Haight has served as the Chief Deputy Clerk at ACCA since November 2022. For the year prior, Mr. Haight served as a Special Advisor on Military Justice to The Judge Advocate General, U.S. Army. On 1 December 2021, Mr. Haight retired from the U.S. Army after more than 28 years of service as an active duty judge advocate.

He deployed to Bosnia in support of Operation Joint Guard (1997) and to Iraq in support of Operation Iraqi Freedom (2004).

Mr. Haight was a Distinguished Military Graduate at Brigham Young University (BYU) where he obtained his Bachelor of Arts degree in Political Science and earned his Juris Doctor degree from the J. Reuben Clark Law School at BYU. He is a graduate of Airborne School, the JAG Officer Basic Course (Honor Graduate), the JAG Officer Advanced/Graduate Course (Honor Graduate), the Army Command and General Staff College, and was a Senior Service College Fellow at the Office of the Director of National Intelligence. He is a member of the Bar of the State of Utah and is admitted to practice law before the Army Court of Criminal Appeals, the Court of Appeals for the Armed Forces, and the U.S. Supreme Court.
